

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
 The purpose of this modification is to (1) provide incremental funding of \$35,000 under Task Order No. 11 for the option period, and (2) revise the work hours under Task Order No. 11 to 6:30 am through 3:00 pm. Accordingly, the task order is hereby modified as follows:
 1. The second sentence of the second paragraph of the definitization letter is revised as follows: "Funds in the amount of \$49,000 are hereby obligated for performance of this task order for the option period." All other terms and conditions of the subject task order remain unchanged. A summary of obligations is provided as follows: FY04 Obligations: \$8,000; FY05 Obligations: \$51,000; FY06 Obligations: \$49,000. Cumulative Obligations: \$108,000. This modification obligates FY06 funds in the amount of \$35,000.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
