14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

Accounting Appropriation Data: RFPA #1 (FFS #10670555C for \$5,000) and RFPA #2 (FFS #10670609C for \$30,000). The purpose of this modification is to provide incremental funding of \$35,000 for the option period. Accordingly, the second sentence of the second paragraph of the definitization letter is revised as follows: (1) "Total funds in the amount of \$46,313.56 are hereby obligated for performance of this task order for the option period." All other terms and conditions of the subject task order remain unchanged. A summary of obligations is provided below: FY 04 Obligations: \$20,000; FY 05 Obligations: \$50,000; and FY 06 Obligations: \$35,000. Cumulative Obligations: \$105,000. This modification obligates FY 06 funds in the amount of \$35,000.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
