James,

The columns labeled First, Second, Third and Fourth, represent calender quarters with First being January - March. The numbers do include both directions of travel on Ross Road. In the second quarter of 2004, 52% of the traffic was north bound and 48% south bound. In the third quarter that number had reversed. On average for the year it was very close to a 50/50 split.

I guess I'm wondering if I can tell how many were heading up or from Ross Road.

A review of our records shows that we counted Ross Road (Converse County Road 31) as a part of our manual count program in both 1998 and 2004. In this program we count a site four time a year, once in each season, by the FHWA scheme F vehicle classification. I have attached the data from those counts.
