Summary: <div style="margin-left: 40px;"> <p>Background: Coatesville Hospital Corporation sent a letter to NRC dated January 20, 2006, under a Brandywine Hospital letter head, notifying NRC that their CEO had changed from Mr. Don Henderson to Mr. Warren E. Callaway, FACHE. In 2001, Brandywine Hospital sold its assets to Coatesville Hospital Corporation (See letter dated May 24, 2001). I contacted Ms. Jean M. Botkin to inquire about the apparent change in hospital names and Ms. Botkin confirmed that there had been no change in assets and that Coatesville Hospital Corporation simply does business as Brandywine Hospital. Based on that information, I requested Ms. Botkin to submit a license amendment requesting the following information:</p> <p>1) Please change the name on the NRC license from Coatesville Hospital Corporation to Coatesville Hospital Corporation, D.B.A. Brandywine Hospital.</p> <p>2) Please confirm that there as been no change in assets and this request is only being made to clear-up any confusion regarding the ownership of the hospital.</p> <p>3) Please change the CEO contact from from Mr. Don Henderson to Mr. Warren E. Callaway, FACHE.</p> </div>

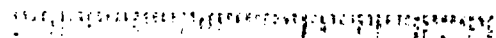
