SUBJECT: APPROVAL OF NRC REVIEW PLAN FOR PLANT LAR'S  
REFERENCING THE CLIIP OF TSTF-423, REVISION 0

The purpose of this memorandum is to request your concurrence on a review plan for plant license amendment requests (LARs) referencing the Consolidated Line Item Improvement Process (CLIIP) for Technical Specification Task Force (TSTF) Change Traveler TSTF-423, Revision 0 (Rev 0), "Technical Specifications End States, NEDC-32988-A," (ADAMS accession number ML032270250). We request your concurrence no later than two weeks from the date of this memorandum. The PRA Branch, Reactor Systems Branch, and Plants Systems Branch have previously concurred on the safety evaluation (SE) approving TSTF-423, Rev 0. Subsequently, the Technical Specifications Branch (ITSB) incorporated the TSTF-423, Rev 0, SE into a model SE and model LAR that can be used to issue amendments adopting TSTF-423, Rev 0, under the CLIIP.

ITSB has received the approval of the NRR Leadership Team to better streamline the CLIIP amendment approval process by developing review plans associated with each CLIIP. The review plans define which technical branches, other than ITSB, that are required to review LARs submitted to adopt these generic technical specification (TS) changes. The review plan for a CLIIP is predicated on a high level of standardization that results from the existence of a model LAR and model SE, which define the level of detail a licensee must include in their plant-specific application. Concurrence on the review plan represents an agreement by the technical

In addition, significant variations from the approach, or inclusion of additional changes to the license, will result in staff rejection of the submittal. Please review and concur on Enclosure 1, the review plan that will be followed when licensees submit LARs to adopt TSTF-423, Rev 0.
