Inova Fair Oaks Hospital would like to notify the Nuclear Regulatory Commission that our Nuclear Medicine service has expanded its activities.

A reconfiguration of the existing facilities has allowed us to add an additional workspace available for Nuclear Medicine procedures. Attached is a modified floor plan to show the location of this modified room. The areas outlined in red are the areas currently indicated on our NRC license. The areas outlined in blue are the new areas. The new doorway has been created as a passageway between these two areas.

This additional room will be subject to the following uses and restrictions:


- (1) To be used primarily as a nuclear cardiac stress testing area
- (2) There will not be storage of radiopharmaceuticals in this room (other than radiopharmaceuticals under direct staff control and intended to be injected into the patient)
- (3) The small room attached to this area is a storage closet. It is used as a non-radioactive storage area.
- (4) All movement of radiopharmaceuticals into this room will be through the new access doorway
- (5) All requirements and license conditions currently in effect will also apply to this new area, including the requirements of 10 CFR 35.70: Surveys of ambient radiation exposure rate.

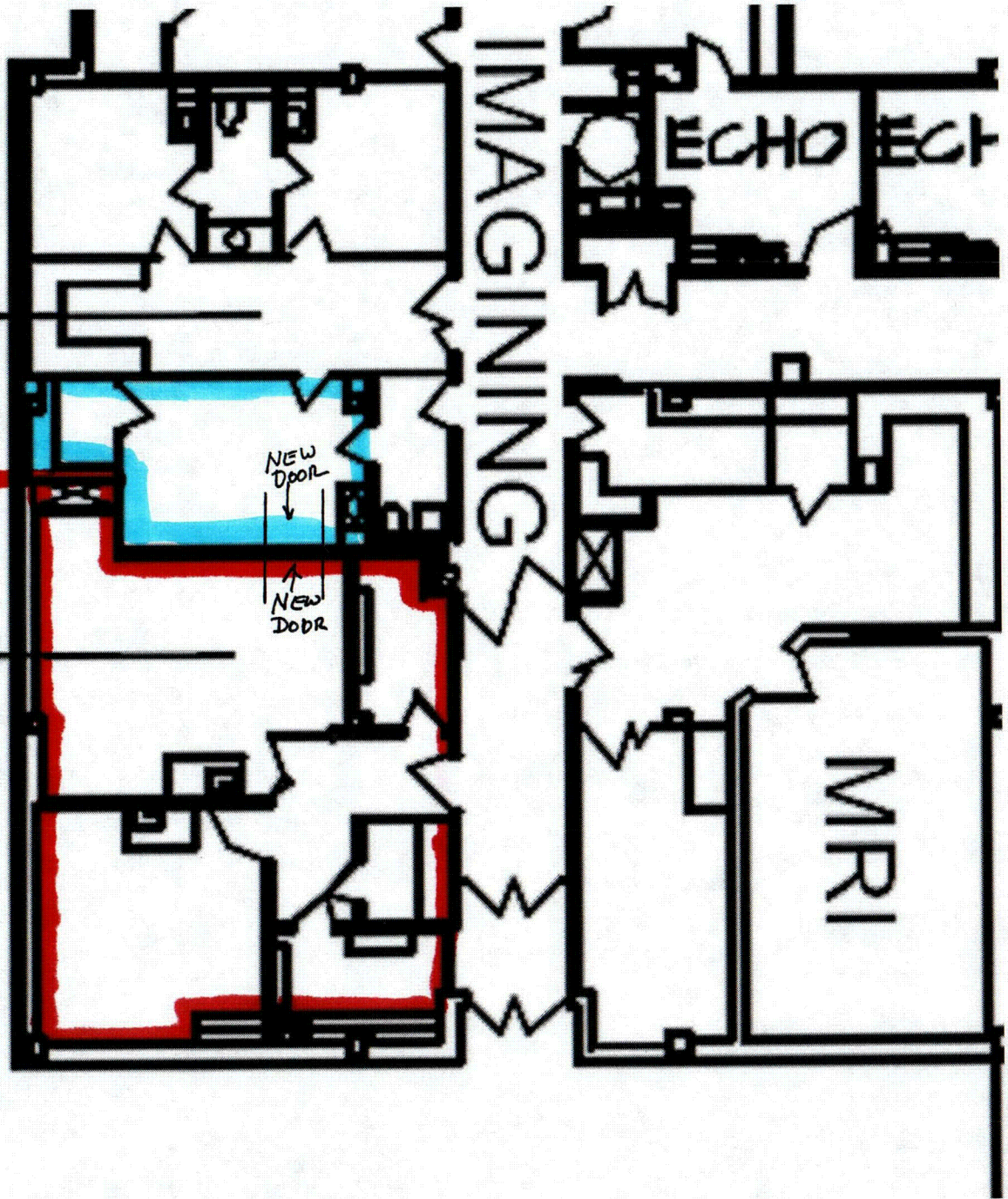
