Mr Fliegel:

I represent Boner Bros. Partnership which owns property bordering Exxon's Highland uranium mine. We have been verbally notified by Exxon's agent, Lou Miller of MFG, Inc., that a plume from Exxon's tailings pond has potentially impacted our property in Section 27, Tn 36N, Rg 72W, in Converse Co. Wyoming. Boner Bros. had requested that Exxon negotiate an MOU with Boner Bros. regarding pre-access agreement conditions prior to the meeting scheduled March 15, 2005. To date we have not been contacted by Exxon.

The purpose of this letter is two fold. First is to reiterate that Boner Bros. is strongly opposed to the termination of Exxon's license, or any action to lessen Exxon's reclamation requirements, at this point in time. Secondly, Boner Bros. respectfully requests that the bonding requirements of this license be reviewed to determine if the coverage is sufficient to provide for costs associated with assessment and restoration this potential plume.
