SUBJECT: SIGNING OF NEW NRC ARRANGEMENTS WITH UKRAINE,  
RUSSIA, AND BULGARIA

PURPOSE:

To advise the Commission of the progress and arrangements which have been made for the signing of three new NRC Arrangements for Technical Cooperation with the State Nuclear Regulatory Committee of Ukraine (SNRCU); the Federal Environmental, Industrial and Nuclear Supervision Service of Russia (ROSTEKHNADZOR); and the Bulgarian Nuclear Regulatory Agency (BNRA).

BACKGROUND:

Since May 1974, NRC has engaged in what has become a broad-scale program of developing and implementing nuclear safety and regulatory information exchange and general cooperation Arrangements with its counterparts in other countries. Originally designed to assure that the operational experience of countries with major commitments to light water reactor (LWR) technology was available to the staff, the NRC's Arrangement and Agreement Program was soon expanded to include countries with only one or two nuclear power plants and then even to some with announced plans to enter the nuclear field. The Office of International Programs administers these bilateral, agency-to-agency-level arrangements, which currently number 38 and involve 35 countries plus Taiwan. (NRC maintains two Arrangements with both Japan and South Africa because they have split ministerial-level regulatory responsibilities.)

As NRC's role in promoting nuclear safety expands, so does the Arrangement and Agreement Program. This year NRC expects to sign three new Arrangements with Ukraine and Russia, as well as Bulgaria.
