Summary:

0845: Spoke with Mr. Miller regarding his faxed letter dated March 3, 2006. Informed Mr. Miller that the required attachments that were referenced in the letter were not included.

1030: Spoke with Mr. Miller regarding the re-faxed documents today, March 13, 2006. Informed him that the required training and experience for Dr. Bashyam was still not documented correctly on the 313A. Specifically, the work experience as listed in the regulations 35.392 and 35.394 is not documented. Mr. Miller stated that he will fax a complete 313A. I also informed him that Dr. Bashyam could not be added for 35.100, as requested on the 313A, because the preceptor is not authorized for 35.100 on the referenced license (Westmoreland Regional Hospital).

I also reminded Mr. Miller that the original letter dated December 16, 2005 requested to add Dr. Bashyam as an AU for oral administration of I-131 and did not include a 35.100 request.

I also told Mr. Miller that the NRC could not accept the unsigned cover letter that was faxed March 13, 2006. Informed Mr. Miller that he could sign the cover letter since the CEO had stated in the December 16 letter that questions be directed to the RSO. Mr. Miller stated that he will re-fax the cover letter today.

Informed Mr. Miller that the deadline for his request is March 24, 2006. He is aware that as of March 25, 2006, those portions of his request that can be processed will be processed, and those portions that have insufficient information to process will be disregarded.

I have made myself available to Mr. Miller on several occasions to ensure he understands exactly what is needed to process the request.
