NRC STAFF ANSWER TO REQUEST FOR A HEARING

On January 4, 2006, the NRC Staff (Staff) issued to David Geisen, an Order Prohibiting Involvement in NRC-Licensed Activities (Effective Immediately).¹ The Order provided Mr. Geisen the opportunity to request a hearing within 20 days of the date of the Order. After an extension, Mr. Geisen responded on February 23, 2006, requesting an expedited hearing on the Staff's Order.² Since Mr. Geisen's February 23 hearing request was timely, the Staff does not oppose it.³
