I also present a 2005 picture from the Hobbs News-Sun showing mention of wind speeds of 75 mph in Hobbs .

To license a uranium enrichment plant which would vent carcinogenic emissions into high winds which would carry them over populated areas would endanger the public health

My second allegation is that NRC officials are withholding the emergency plan for the Les uranium enrichment plant from the public to facillate the licensing of the plant. In case of an emergency at the proposed LES plant no one down wind of the plant would know what to do. This would place the public at risk.

For the public good, I will also forward this letter onto insurance companies that do business in the state.
