| Summary:   | <p>Ms. Earle was called regarding followup information necessary to support continued action to terminate or otherwise change the Proxtronics license. As documented in a 2/15/2006 phone conversation (ML060480479), Mr. Guy Davis was requested to provide the most recent leak test results for sources transferred to the University of Georgia and a determination relative to the licensee's desire to keep or terminate the existing license considering that the licensee apparently does not want to pursue the amendment request dated 12/12/2005.</p> <p>Ms. Earle reported that Mr. Davis is out of the country for an extended period of time but that she had discussed my request for this information with him. He stated that he believes that they had already provided this information via an NRC Form 314 dated 11/1/2005. This form was reviewed with Ms. Earle and it was confirmed that the leak test results are still needed and no communication relative to license termination has yet to be communicated to the NRC.</p> <p>Ms. Earl stated that she will be communicating with Mr. Davis and will have him call me direct or gather the appropriate information to complete this licensing action. In any event, I informed Ms. Earl, that failure to provide me with the above requested information tomorrow will result in a voiding of this licensing action. With this approach, the licensee will be able to decide wether they want this license terminated at this time or not.</p> |  |
