14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to provide incremental funding under the subject task order which increases the obligated amount by \$15,000 from \$45,500 to \$60,500. Accordingly, the task order is hereby modified as follows:

The fifth sentence of the definitization letter is revised as follows: "Funds in the amount of \$60,500 are hereby obligated for performance of this task order." All other terms and conditions of the subject task order remain unchanged. A summary of obligations is provided below:

FY'05 Obligations: \$25,500; FY'06 Obligations: \$35,000. Cumulative Obligations: \$60,500.

This modification obligates FY'06 funds in the amount of \$15,000.
