This is in reference to your application dated March 20, 2006 requesting to renew Nuclear Regulatory Commission License No. SNM-1946. In order to continue our review, we need the following additional information:

1. For sealed sources, provide a list of all manufacturers and model numbers that you currently possess or may use in the future.
2. Your application does not specify the individual to be Radiation Safety Officer. Verify that Norman Bischoff will remain as Radiation Safety Officer. If Mr. Bischoff is not to remain as the Radiation Safety Officer, submit the name and qualifications of the proposed Radiation Safety Officer.
3. In your application, you did not specify the method and frequency for training. Provide a description of the method and frequency of the training program described in your application.
