L-3 is hereby directed to give immediate effect to the changes listed below. All work is to be performed in accordance with the terms and conditions of the task order.

- Add a core service band (CSBGFEAppl1) for a government-furnished network appliance (hardware/software bundled device) that performs a network function not otherwise required under the task order. Network appliances may include devices from NCircle, Finjan, IronPort, and others. L-3 is to provide service and support for each appliance (Est. Qty.: 4) identified and authorized\* by the Project Officer; and
- Add a core service band (CSBPCCIEN1A) for services required to support the use of Product Class PCCIEN1A (Inter-network Black Box Connectivity Interface) in NRC Headquarters locations. L-3 is to provide service and support for each appliance (Est. Qty.: 1) identified and authorized\* by the Project Officer as listed below.

*\*No item or service shall be added to the Seat environment, nor shall any item or service be considered to incur a Seat cost under this Task Order without specific written authorization from the Project Officer. Authorizations may be made via electronic mail and may be made by the Alternate Project Officer in the absence of the Project Officer. Other forms of request such as NRC Infrastructure Technical Change Requests (TCRs) or Work Orders for performance under the level of effort portion of this Task Order shall not be accepted as authorizations for any seat products or services, including those listed in this modification.*

Reference is made to L-3's proposal dated February 8, 2006 to add the above core service bands. Upon completion of negotiations, a supplemental agreement will be issued to incorporate an equitable adjustment for these changes.

Except as provided herein, all other terms and conditions remain unchanged.
