The purpose of this modification is to (1) provide incremental funds of \$5,000, and (2) revise the Technical Monitor to Russell Nichols (the Alternate remains at Becky Menefee) under Task Order No. 2. Accordingly, the task order is hereby modified as follows:  
1. The second sentence of the second paragraph of the definitization letter is revised as follows: "Funds in the amount of \$16,313.56 are hereby obligated for performance of this task order for the option period."  
All other terms and conditions of the subject task order remain unchanged.
