The purpose of this modification is to: (1) extend the period of performance through September 26, 2006, and (2) increase the contract ceiling by \$15,000.00 for delivery orders. Accordingly the contract is hereby modified as follows:

1. Under Section B.3, Consideration and Obligation–Delivery Order, the first sentence of paragraph (a) is revised as follows:

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$195,200.00.”

2. Under Section F.2, Duration of contract Period is revised as follows:

“F.2 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 1 (JUN 1988)

The period of performance and the ordering period for this contract shall commence on 09/27/2004 and will expire on September 26, 2006. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering).”
