The purpose of this modification is to (1) add a within scope requirement labeled Task 5a, entitled "OCFO Reporting" (2) increase consideration and obligation by \$1,461.00 from \$160,824.60 to \$162,285.60 and (3) extend the expiration date from February 28, 2006 to May 31, 2006. Accordingly the contract is modified as follows:

1) **Additional Task:** **Task 5a. "OCFO Reporting"** **\$1,461.00**

OCFO needs additional information in the form of the following six charts:

- 1 chart providing OCFO "unfavorable" Category Scores Ranked by Difference from NRC Overall.
- 1 chart providing OCFO "unfavorable" Category Scores Ranked by Difference from U.S. National Norm.
- 1 chart providing OCFO "unfavorable" Category Scores Ranked by Difference from OCFO 2002.
- 1 chart providing OCFO "?" Category Scores Ranked by Difference from NRC Overall.
- 1 chart providing OCFO "?" Category Scores Ranked by Difference from U.S. National Norm.
- 1 chart providing OCFO "?" Category Scores Ranked by Difference from OCFO 2002.

2) Section B.3 entitled, "Consideration and Obligation-Firm-Fixed Price (Jun 1988) is hereby deleted in its entirety and replaced with the following:

"The firm fixed price of this contract is \$162,285.60"

3) Section F.2 "Duration of Contract Period (Mar 1987) is hereby deleted and replaced with the following:

"The contract shall commence on March 24, 2005 and will expire on May 31, 2006"

This modification obligates funds in the amount of \$1,461.00.

All other terms and conditions remain the same.
