Duane Arnold Energy Center Security Plan Change No. 2 and Response to Request For Additional Information

The Duane Arnold Energy Center (DAEC) Security Plan has been revised to address a Request For Additional Information regarding Revision 1 of the Security Plan, incorporation of changes required due to the sale of DAEC to FPL Energy Duane Arnold, LLC (FPL Energy Duane Arnold) and transfer of the Facility Operating License from Nuclear Management Company, LLC (NMC) to FPL Energy Duane Arnold on January 27, 2006, incorporation of changes required for modification of a barrier, and incorporation of language recommended in Security Frequently Asked Questions (SFAQ) 04-04, 04-09, and 05-03 Revision 1. The revised Plan maintains compliance with 10 CFR requirements and NRC Orders. It has been determined these changes do not reduce the effectiveness of the DAEC Security Plan and therefore, the changes have been made pursuant to 10 CFR 50.54(p). Enclosure 1 contains FPL Energy Duane Arnold's response to the NRC Request for Additional Information regarding Revision 1 of the Security Plan, a description of the Security Plan changes is included in Enclosure 2, Enclosure 3 contains a 10 CFR 50.54(p) Evaluation Summary, and Enclosure 4 contains the revised Security Plan.

This letter contains no new commitments and no revisions to existing commitments.


