These assets consisted of APAC Richmond operations <u>only</u> and included two (2) nuclear testing devices, both of which are 4640 models and previously incorporated under License No. 45-21343-02, Docket No. 030-33317. The Interstate Materials License as referenced above currently accepts the 4640 gauging devices so to the best of my knowledge, no changes are necessary regarding this.
