SUBJECT: TERMINATION OF YOUR NRC RADIOACTIVE MATERIALS LICENSE

On February 21, 2006, you contacted the U.S. Nuclear Regulatory Commission and indicated that you wished to terminate your NRC radioactive materials license. The NRC staff has reviewed your sealed source leak test results, which documents there was no evidence of leakage of radioactive material from the sealed sources. Based on its review, the staff has concluded that all licensable radioactive material has been removed from your facility and the facility is authorized for unrestricted use in accordance with 10 CFR 20.1402, "Radiological Criteria for Unrestricted Use." An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(20)(ii).

Based on these conclusions no further remediation or actions with respect to NRC regulated material is required. Your facility is suitable for unrestricted use and NRC license number 53-27769-01 for your facility at 841 Bishop Street, Suite 2006, Honolulu, Hawaii 96813, is hereby terminated.

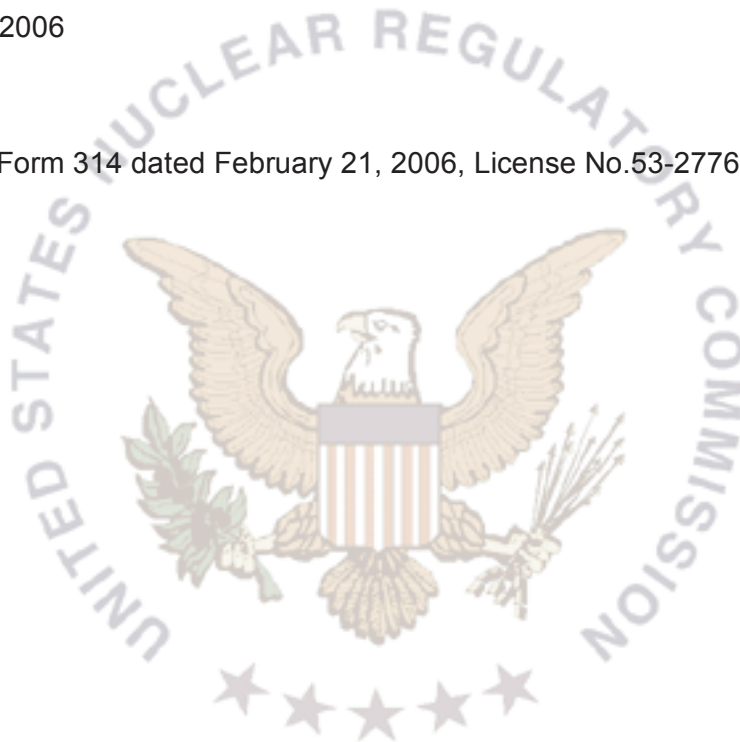
