By letter dated March 1, 2006, QSA Global, Inc. (QSA) submitted an application to the U.S. Nuclear Regulatory Commission (NRC) requesting an amendment to the Certificate of Compliance (CoC) for the Model No. 650L to include Se-75 and to update the CoC to comply with the recent changes to 10 Code of Federal Regulations Part 71 or "-96 update."

This is to inform you that the application appears to contain the necessary information to begin our technical review. The schedule below establishes the key milestones and dates associated with the review. Please note that the schedule allows for the staff to issue a possible request for additional information (RAI) in June 2006. If no RAI is needed, and based on the staff's evaluation, our Safety Evaluation Report and CoC may be issued at approximately that time.

In general, no additional changes to the application will be allowed except for those minor changes or minor supplements that result in responding to an RAI. Additional changes, supplements, or enhancements may be treated as a new application.
