>

> I have attempted to contact each of you by telephone, since my attempt on February 27, 2006, to inspect the NRC license issued to the Hampton University, Center for Advanced Medical Instrumentation, for use of certain radioactive materials at Jefferson Laboratories. On February 27, I was unable to reach Dr. Kieper, who is listed on the license as the Radiation Safety Officer, during my visit to Jefferson laboratories. At that time, the receptionist at Jefferson Labs was able to have Dr. Gueye get in touch with me by telephone. Dr. Gueye told me that Dr. Kieper is no longer the Radiation Safety Officer for the license, but that he now has responsibility for the lab that would use NRC-licensed materials. Dr. Gueye also said that no radioactive materials have ever been received under this license, which was issued in November 2002. I informed Dr. Gueye during that conversation that Hampton University must send a letter to the NRC requesting to change the Radiation Safety Officer, and that until a new Radiation Safety Officer is approved, you cannot work under this license.

> To date, the NRC has not received such a letter.

>

> In order to complete my inspection, I need to confirm the name(s) and mailing address(es) of persons who should receive correspondence related to this inspection. The current mailing address is Physics, Olin 102, Hampton, VA 23668. however, I did not find either of you listed as faculty in the Department of Physics, so I am unsure if mail will reach you at this address.
