Purpose of Meeting: An open predecisional enforcement conference will be held to discuss two apparent violations identified during a routine inspection conducted at the licensee's main office and a temporary job site on January 12, 2006. The apparent violations involved the licensee's failure to maintain a minimum of two independent physical controls to prevent unauthorized removal of a licensed nuclear gauge while the gauge was not under the direct control and constant surveillance of the licensee, and the subsequent failure of the licensee to make a timely written report regarding theft of the licensed nuclear gauge.
