The purpose of this modification is to deobligate excess funds in the amount of \$2,908.88 from \$634,375.00 to \$631,466.12. According, the contract is modified as follows:  
  
Under Section B.5, "Consideration and Obligation-Work Orders (JUN 1988)" the first sentence of paragraph (b) is deleted in its entirety and replaced with the following:  
" (b) The amount presently obligated with respect to this contract is \$631,466.12."  
  
This modification deobligates FY05 funds in the amount of \$2,908.88.
