14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)  
This confirms verbal authorization provided by Jeff McDermott and given to Toby Studley, SPS Consultants, on 2/26/06 for an increase of \$30,358 for the option period under T.O. 13. The purpose of this modification is for: (1) an extension of 6 months effective 2/26/06 - 8/26/06, and (2) provision of incremental funds. Accordingly, the task order is modified as follows: 1. The second paragraph of the definitization letter is revised to read: "The option period is hereby exercised by the Government in accordance with Section C.7 of the contract, for the period August 27, 2005 through August 26, 2006, at an estimated cost of \$60,716. Funds in the amount of \$60,716 are hereby obligated for performance of this task order for the option period." All other terms and conditions of the subject task order remain unchanged. A summary of obligations is provided as follows: FY05 Obligations: \$59,602.80 and FY06 Obligations: \$30,358. Cumulative Obligations: \$89,960.80. This modification obligates FY06 funds of \$30,358.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
