This memorandum is to inform you of the Nuclear Regulatory Commission's (NRC) use of the radio spectrum and the National Telecommunications and Information Administration's (NTIA) role in managing the radio spectrum on behalf of the Federal government and seeks your approval by signature of two Memoranda of Understanding (MOU), enclosed, between the NRC and NTIA. The MOU dated December 14, 2005, is for Fiscal Year 2006 with an amount due of \$1,293.00, and the MOU dated March 2, 2005, is for Fiscal Year 2005 with an outstanding amount due of \$1,187.00.

Under Public Law 109-108, Science, State, Justice, Commerce, and Related Agencies Appropriations Act for Fiscal Year 2006, Congress requires NTIA to charge Federal agencies for the cost of NTIA spectrum management operations and related services. As such, NTIA has submitted its FY2006 Revised Agency Prorated Reimbursement schedule as part of the MOU. The reimbursement scheduled is allocated based upon the percentage of radio frequencies in use by a particular agency as compared to the entire Federal government. The NRC has twelve (12) frequencies that are used for both administrative as well as emergency operations.
