In accordance with 10 CFR 30.38, and pursuant to your letter of March 13, 2006 <u>AVAX</u> <u>TECHNOLOGIES INC.</u>, <u>REQUEST FOR ADDITIONAL INFORMATION CONCERNING</u> <u>APPLICATION FOR AMENDMENT TO LICENSE, CONTROL NO. 138308</u>, we submit the following: a change request in compliance with NUREG-1556, Vol. 5, appendix G for requesting a change of RSO on a license for a self-shielded irradiator.

The requested change requires a name change in line item #12 from Craig E. Broecker to Henry E. Schea III. All other items are unchanged. Craig is no longer considered the Radiation Safety Officer (RSO) for AVAX Technologies, Manufacturing Facility, Philadelphia, PA.

Henry has assumed the responsibilities of the RSO effective on 01/23/2006 as stated in a letter sent to your office on that date. AVAX Technologies requests that the license reflect this change effective on or after 01/23/2006.

In order to establish proper qualification to serve as RSO Henry has completed the following:

- 1. A training course entitled Basic Radiation Safety provided by Landauer.
- 2. Training in the basic operation of the Gamma Cell 1000 given by David Berd, MD, who is an authorized user with more than 5 years experience with the Gamma Cell 1000.
- 3. Review of NUREG-1556, Vol. 5
- 4. Review of the Site Master's Manual provided by MDS Nordion for the Gamma Cell 1000.
- 5. Programming the Gamma Cell 1000 using the Site Master menu.
- 6. Review of the Troubleshooting Manual for the Gamma Cell 1000.
