The President of the United States in a memorandum dated December 16, 2005, delineated guidelines and requirements in support of the information sharing environment. One of the requirements states that each head of an executive department or agency shall designate a senior official for controlling, communicating and coordinating its information sharing program, to include terrorism information. As the Executive Director for Operations, I believe you are the appropriate senior manager within the NRC to control and coordinate the various functions related to information sharing with Federal, State, local, tribal agencies, and as appropriate, with private sector entities. Therefore, I am designating you as the NRC's senior official for controlling, communicating and coordinating the NRC's information sharing program.

Please note that while the Office of Nuclear Security and Incident Response handles the majority of terrorism-related information for the NRC, overall control of information sharing with other agencies and entities resides with you.
