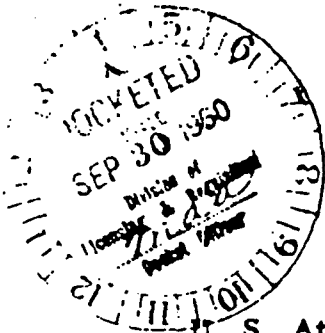

Gentlemen:

Effective September 30, 1960, all the nuclear fuel business now being carried on by Mallinckrodt Nuclear Corporation, a wholly-owned subsidiary of Mallinckrodt Chemical Works, will be transferred to Mallinckrodt Chemical Works. The transfer will include physical assets, contracts, licenses and all other property now being utilized by Mallinckrodt Nuclear Corporation in this business. It is also contemplated that all of the personnel now engaged in these activities will be transferred to Mallinckrodt Chemical Works on that date.

It is requested that the licenses issued to Mallinckrodt Nuclear Corporation, identified as ENM-33 and C-5014, as such licenses have been amended from time to time, be transferred to Mallinckrodt Chemical Works, or in the alternative, that new licenses identical to those identified above be issued to such Corporation. In either event, the effective date of the licenses should be October 1, 1960.

There is on file with your organization information as to the date of incorporation and names of directors and officers of Mallinckrodt Chemical Works. If you wish this information reaffirmed or require additional information, we will be pleased to comply with your request.

The Mallinckrodt Chemical Works agrees to perform the licensed activities now carried on by Mallinckrodt Nuclear Corporation in accordance
