On August 5, 2005, Duke Energy Corporation, currently Duke Energy Carolinas (Duke), submitted to the Nuclear Regulatory Commission (NRC), an Application for Consent to the Indirect Transfer of Control of Licenses and for Conforming License Amendments Pursuant to 10 CFR 50.80, 10 CFR 50.90, 10 CFR 72.50, and 10 CFR 72.56 (Application). In the Application, Duke told the NRC that when the information became available, the Application would be supplemented with the names, addresses, and citizenships of the Board of Managers of the licensee, Duke.

On November 28, 2005, we advised the NRC that the Board of Managers for Duke would be selected when the merger closes, or shortly before that date, and confirmed that at least 90% of the Board of Managers would be U.S. Citizens.
