This letter and the enclosed NRC Form 591M refer to the safety inspection conducted on March 23, 2006, at your field office in Bozeman, Montana. The inspection was an examination of activities conducted under your license as they relate to safety and compliance with the Commission's rules and regulations and with the conditions of your license. Within these areas, the inspection consist of selected examinations of procedures, representative records, and interviews with personnel. A preliminary exit briefing was conducted with Mr. Casey Ballard of your staff at the conclusion of the on-site portion of the inspection.
