The purpose of this modification is to obligate incremental funding in the amount of \$11,000.00 thereby increasing the amount of this contract from \$2,524,736.00 to \$2,535,736.00. Accordingly, the contract is modified as follows:

1. Section B.1.4, "CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUNE 1988)," the first sentence in paragraph (b)" is revised to read as follows:

"(b) The amount presently obligated with respect to this contract is \$2,535,736.00."
