


The purpose of this modification is to increase the Maximum Ordering Limitation (MOL) by \$259,990.00 from \$3,248,320.00 to \$3,508,310.00. Accordingly, the contract is modified as follows:

Section B.3, CONSIDERATION AND OBLIGATIONS – TASK ORDERS (AUG 1989) ALTERNATE 1 (JUN 1991), paragraph (a) is deleted in its entirety and the following is substituted in lieu thereof:

- “a. The Maximum Ordering Limitation (MOL) for products and services ordered, and accepted under this contract is \$3,508,310.00. The Contracting Officer may place orders with the Contractor during the contract period provided the aggregate amount of the orders does not exceed the MOL.”

As a result of this modification, the ceiling amount is increased to \$3,508,310.00. All other terms and conditions remain the same.

This modification does not obligate funds.
