This is in reference to your letter dated March 9, 2006 requesting to amend Nuclear Regulatory Commission License No. 37-17860-02. Specifically, you requested to complete the decommissioning of the Quehanna Site under Revision 4 of the Decommissioning Plan (DP). This revision of the DP provides a revised approach for unrestricted release of the site under 10 CFR 20, Subpart E. We have completed our initial acceptance review of your revised DP and have determined that your submission is sufficiently complete for NRC to initiate a detailed technical review.

Our consideration of your Amendment Request will be published in the Federal Register, along with a notice that any person whose interest may be affected by the proceedings may file a request for hearing in accordance with Subpart C of 10 CFR 2.
