2) Physical Description

This shipment consists of 22 x 48Y Cylinders loaded on 1 lash barge (22 cylinders per barge). RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U – 181,170 kgs.
