By letter dated March 6, 2006, QSA Global, Inc. (QSA) submitted an application for Amendment 7 of Certificate of Compliance (CoC) No. 9187. This application requested a "- 96" identification for QSA's Model No. 865 Transport Package and a change to reflect QSA's new ownership of AEA Technology QSA Inc.

This letter is to acknowledge receipt of your application and inform you that the application appears to contain the necessary information to begin our technical review. We have established a schedule for the technical review of your amendment request. The schedule allows for the staff to issue a possible request for additional information (RAI) in June 2006. If no RAI is needed, and based on the staff's evaluation, the amended CoC may be issued at approximately that time.

In addition, we note that the quality assurance (QA) program, required by Title 10 Code of Federal Regulations Part 71, is still under the organizational name of AEA Technology QSA Inc., although the organization is under new ownership and name. QSA is required to have its QA program description revised to reflect new ownership and name. This revision must occur before the CoC can be revised to reflect QSA's new ownership.

In general, no additional changes to the application will be allowed except for those minor changes that result in responding to an RAI. Additional of changes, supplements, or enhancements may be treated as a new application.
