

The purpose of this modification is to: (1) extend the period of performance through July 31, 2006; (2) add options to extend the period of performance for two one-month extensions; (3) increase the total amount of the contract by \$100,480.00, from \$1,290,749.39 to \$1,391,229.39, and increase the obligated amount by \$104,480.00 from \$1,290,79.39 to \$1,391,229.39. Accordingly, the contract is modified as follows:

1. **Item 15G of Standard Form 26** is deleted entirely and replaced with the following:

"TOTAL AMOUNT OF CONTRACT: \$1,391,229.39"

2. **Section B.3, CONSIDERATION AND OBLIGATION - LABOR HOURS FOR REGULAR WORKING HOURS**, is deleted entirely and replaced with the following:

"Section B.3, CONSIDERATION AND OBLIGATION

- (a) The total ceiling amount of this contract is \$1,391,229.39. Payment will be made on a bi-monthly basis upon completion of all required services for that performance period.
- (b) The total obligated amount by the Government with respect to this contract is \$1,391,229.39. The Contractor shall not incur cost over the obligated amount unless a written contract modification is issued by the NRC Contracting Officer."

3. **Section B.3.1, CONSIDERATION AND OBLIGATION- FIXED PRICE (OPTION YEARS)**, is deleted entirely and replaced with the following:

- "(a) The total ceiling amount of this contract for the Base Period of Performance is \$232,172.38.
The Firm Fixed Price of this contract for Option Year One is \$237,666.71.
The Firm Fixed Price of this contract for Option Year Two is \$260,400.00.
The Firm Fixed Price of this contract for Option Year Three is \$273,419.66.
The Firm Fixed Price of this contract for Option Year Four is \$287,090.64.
The Firm Fixed Price of this contract for the 4 month extension (4/1/2006 to 7/31/2006) is \$104,480.00.
The Firm Fixed Price of this contract for the one moth option (8/1/2006 to 8/31/2006) is \$25,120.00.
The Firm Fixed Price of this contract for the one moth option (9/1/2006 to 9/30/2006) is \$25,120.00.

- (b) The amount presently obligated with respect to this contract is \$1,391,229.39."

"This contract shall commence on April 1, 2001, and will expire on July, 2006. The term of this contract may be extended at the option of the government for an additional two one-month option periods."

Option Period 08/01/2006 – 08/31/2006 may be exercised unilaterally by the NRC provided that 15-day written notification of intent is provided to ProBuilders in accordance with FAR 52.217-9. The option may be exercised bilaterally if proper notification is not provided. Monthly terms, conditions and prices remain the same as Modification No. 13.

Option Period 09/01/2006 – 09/30/2006 may be exercised unilaterally by the NRC provided that 15-day written notification of intent is provided to ProBuilders in accordance with FAR 52.217-9. The option may be exercised bilaterally if proper notification is not provided. Monthly terms, conditions and prices remain the same as Modification No. 13.

All other terms and conditions of this contract remain unchanged.
