The purpose of this modification is to: 1) Exercise the Option Year 2 to extend the period of performance of the contract from September 2, 2004 through February 1, 2007; 2) Increase the ceiling amount of this contract by \$160,272.00 from \$240,052.00 to \$400,324.00; and 3) provide incremental funding in the amount of \$182,000.00, thereby increasing the obligated amount of this contract from \$205,780.00 to \$387,780.00.

Accordingly, the contract is hereby modified:

1. Item No. 26, TOTAL AWARD AMOUNT, on Standard Form 1449 is DELETED entirely and REPLACED with the following:

"TOTAL AWARD AMOUNT: **\$400,324.00.**"

2. Section B.2, CONSIDERATION AND OBLIGATION, is DELETED entirely and REPLACED with the following:

"B.2 CONSIDERATION AND OBLIGATION

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is **\$400,324.00**. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.

(b) The amount presently obligated with respect to this contract is **\$387,780.00**. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

2. Section C.7, DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987), is DELETED entirely and REPLACED with the following:

"C.7 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987)
This contract shall commence on September 2, 2004 and will expire **February 1, 2007**. The term of this contract may be extended at the option of the Government for **two (2)** additional one-year periods."

3. Section 8.0, PERIOD OF PERFORMANCE, of the Statement of Work (SOW) is DELETED entirely and REPLACED with the following:

"8.0 PERIOD OF PERFORMANCE

The period of performance for this work shall be September 2, 2004 through **February 1, 2007** with **two (2)** additional option years."

All other terms and conditions of the subject contract remain unchanged.
