**SUBJECT:** LEXINGTON CARDIOLOGY ASSOCIATES, REQUEST FOR ADDITIONAL INFORMATION CONCERNING APPLICATION FOR AMENDMENT TO LICENSE, CONTROL NO. 138732

Dear Dr. Borkowski:

This is in reference to your letter dated April 12, 2006 requesting to amend Nuclear Regulatory Commission License No. 06-28640-02. In order to continue our review, we need the following additional information:

Your request to add Manny Chris Katsetos, M.D. as an authorized user does not contain all of the information required by 10 CFR 35.290. You have provided, for our review, certification that Dr. Katsetos is licensed to practice medicine in the State of Connecticut and is certified by a specialty board recognized by the Commission. However, your request did not include a written attestation signed by a preceptor authorized user who meets the requirements in 10 CFR 35.290 or in 10 CFR 35.390 and 10 CFR 35.290(c)(1)(ii)(G), or equivalent regulations of an Agreement State. Since you have submitted information on the training of Dr. Katsetos under 10 CFR 35.290(a)(1), the attestation must state that the individual has satisfactorily completed the requirements in 10 CFR 35.290(a)(1) and has achieved a level of competency sufficient to function independently as an authorized user for the medical uses authorized under 10 CFR 35.100 and 35.200.
