ABB Prospects Inc. (ABB) is submitting the Final Status Survey (FSS) Report for the Building 5/6A Complex portions of the CE Windsor Site. An additional FSS Report is forthcoming for all remaining portions of the Site (excluding explicitly designated FUSRAP areas). Activities described in the CE Windsor Site Decommissioning Plan have been performed and are summarized in the FSS Report for this portion of the Site.

ABB has complied with the decommissioning requirements set forth in 10 CFR 30.36 and 10 CFR 20, subpart E, for the Building 5/6A Complex by completing activities described in the Decommissioning Plan.
