Dear Administrative Judges:

Attached please find the "NRC Staff and Concerned Citizens of Honolulu's Proposed Hearing Schedules." The Staff and Concerned Citizens were able to agree to one schedule in the event that the Board accepts the proposed joint stipulation regarding the admitted environmental contentions and one schedule in the event that the Board does not accept the proposed joint stipulation. Pa'ina Hawaii was consulted regarding both schedules, but was not able to agree to either schedule. Both schedules are based on the Model Milestones for hearings under 10 C.F.R. Part 2, Subpart L in Appendix B to 10 C.F.R. Part 2 and the amount of time that the Staff estimates is necessary to complete either an Environmental Analysis (EA) under the proposed joint stipulation or an environmental review of issues related to the environmental contentions prior to completing testimony. The Staff's estimate is based on the minimum amount of time granted for completion of an EA under the Staff's generic EA schedule for a materials application.

² While the Model Milestones provide 30 days from the issuance of the SER for late-filed contentions, additional time is proposed to account for the intervening winter holidays. This additional time does not affect the remaining deadlines, including the hearing date, which follow the Model Milestones.

³ This schedule assumes the Staff reaches a FONSI as a result of the EA. If the Staff determines an EIS is needed, the schedule would have to be adjusted to allow for additional environmental review.

⁴ 10 C.F.R. § 51.33(c)(3) provides for a minimum of thirty (30) days for public comment on a draft FONSI. An additional week for public comment is proposed to account for the intervening winter holidays. The deadlines for actions triggered by issuance of the SER has been shortened from the Model Milestones' recommendations to ensure the additional time for public comment does not lengthen the time needed to conclude the hearing.
