Dear Mr. Bondre:

The U.S. Nuclear Regulatory Commission is issuing Revision 14 of Certificate of Compliance (CoC) No. 9016 for the Model No. TN-9 package. Revision 14 corrects a typographical error in Revision 13 of the CoC.

Revision 13 renewed the CoC and updated the expiration date to October 1, 2008. At that time, Condition No. 16 was added to the CoC to address the use of overlapping certificates. Condition No. 16 should have referred to the previous version (Revision 12) and not to the current version (Revision 13). To correct the typographical error, CoC No. 9016, Revision 14 authorizes the use of Revision 12 and Revision 13 for a period of one year.

The approval constitutes authority to use the package for shipment of radioactive material and for the package to be shipped in accordance with the provisions of 49 CFR 173.471. Those on the attached list have been registered as users of the package under the general license provisions of 10 CFR 71.17 or 49 CFR 173.471. Registered Users may request by letter to remove their names from the Registered Users List.

SUMMARY

Revision 14 of Certificate of Compliance (CoC) 9016 for the Model No. TN-9 package will correct a typographical error identified in Revision 13 of the CoC.

EVALUATION

Revision 13 of CoC No. 9016 for the Model No. TN-9 package was issued to renew the CoC and update the expiration date to October 1, 2008. Revision 13 added Condition No.16 to the CoC to address the use of overlapping certificates and to authorize the previous revision of the CoC for a period of one year. Condition No. 16 should have referred to the previous version or Revision 12. However, a typographical error in Condition No. 16 incorrectly referenced Revision 13. The typographical error has been corrected in Revision 14. As a result, Revision 14 authorizes the use of Revision 12 and Revision 13 for a period of one year.

CONCLUSION

Certificate of Compliance No. 9016, Revision 14 corrects the typographical error in Revision 13.
