In Management Directive 9.20, "Organizations and Functions, Office of the Chief Financial Officer," the Commission delegated to the Chief Financial Officer the authority to develop and promulgate rules as defined in the Administrative Procedures Act (5 U.S.C. 551(4)), subject to the limitations of that memorandum.

The enclosed final rule amends 10 CFR Parts 170 and 171. These amendments are necessary to implement the requirements of the Omnibus Budget Reconciliation Act of 1990, as amended, to recover approximately 90 percent of the NRC's FY 2006 budget authority through license and annual fees.

The final rule is consistent with Commission fee policy decisions, does not constitute a significant question of policy, nor does it amend regulations contained in 10 CFR Parts 7, 8, or 9 Subpart C concerning matters of policy. I therefore find that this rule is within the scope of my rulemaking authority and am proceeding to issue it.
