Dear Dr. Oglesby:

This is in reference to your letter dated May 1, 2006 requesting to amend Nuclear Regulatory Commission License No. 29-30390-01. In order to continue our review, we need the following additional information:

1. Please provide information related to the total square footage of the entire facility, i.e., office space, laboratory area, waste storage area, etc. Also, provide the square footage of each of the affected areas, i.e., waste storage area, wet laboratory, sample log-in area, and instrumentation laboratory.
2. Describe the areas surrounding the facility as to type of use: Residential, commercial, Industrial, or mixed residential/commercial.
3. On what day was licensed material last used at the facility?
4. Examining your data, it is difficult to determine whether you determined your own DCGL's or used those provided for the radioisotopes of concern in NUREG-1727, Volume 2. Please clarify how you arrived at your DCGL's.
