The revised physical security plans, training and qualification plans, and safeguards contingency plans for the Exelon and AmerGen facilities that were affected by the Order are contained on the enclosed CD-ROM. Exelon and AmerGen have concluded that the changes as described in the attachment do not decrease the safeguards effectiveness of the Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan for affected facilities.

Therefore, Exelon and AmerGen request that the enclosed CD-ROM be withheld from public disclosure in accordance with 10 CFR 2.390, "Public inspections, exemptions, requests for withholding," paragraph (a)(1)(i), and 10 CFR 73.21, "Requirements for the protection of safeguards information," paragraph (b)(1)(i).
