
Alaron Corporation is a subsidiary of Onyx Environmental Services L.L.C. (shortly to change its name to Veolia ES Technical solutions, L.L.C.) Onyx/Veolia provides hazardous waste packaging, shipping, treatment, and disposal services for customers all across the United States and in Puerto Rico. Onyx/Veolia is frequently asked to provide radioactive and mixed waste services for these same customers and has done so when the work can be done under the customer's radiation protection program/radioactive material license. There are however, situations where the customer is unable or unwilling to have packaging and shipping work done under their program/license.

Alaron intends to have a small number of Onyx/Veolia environmental service technicians qualified and operate under Alaron's radiation protection program and license in these instances to package and ship radioactive waste for the customer either to Alaron's Wampum, Pennsylvania facility or to other radioactive waste processors. In those instances where the customer is located in an agreement state, Alaron would seek the appropriate reciprocity arrangements and notifications with the individual agreement states before proceeding.

Since Alaron already receives, processes, packages, and ships radioactive waste, the only change from our previous submittals is the location (item 3 on NRC Form 313) expanded to include temporary job sites.
