**Adoption of Policies and Procedures and
Certification of Eureka County LSN Document Collection**

Eureka County Commissioners adopt the policies as set forth in our Policy and Procedure Manual in connection with certification of Eureka County's Licensing Support Network (LSN) System and certify that the document collection, which is available to the NRC's Licensing Support Network, meets the rules and guidelines as set forth in the NRC Regulations Title 10, Code of Federal Regulations. Eureka County has followed the guidelines and rules as they apply in connection to the Nuclear Regulatory Commission's LSN and in doing so are supplying the Pre-Application Presiding Officer Board (PAPO) the following resolution in the case that any problem should arise that we have not already identified and resolved as to the integrity of our documentary material collection in accordance with § 2.1009(b).

Eureka County recommends that disputes arising from any unforeseen problems involving the LSN availability of our document collection or integrity of our documentary material require that any person, party or entity requesting a resolution to a dispute send a certified letter stating their dispute and their requested resolution to the Director of Public Works, Eureka County, PO Box 714, Eureka, NV 89316. The Director of Public Works upon receipt of the request for resolution will respond to the person, party or entity within 10 working days of receipt via certified letter.

Further, Eureka County's Board of County Commissioners have read, made recommendations and now adopt our current April 2006 Eureka County Nuclear Waste Oversight Program Policy and Procedures to Participate in the Nuclear Regulatory Commission Licensing Support Network System.
