## C.I.13.3, Emergency Planning Regulations

- NRC and DHS have joint responsibility for the review of EP
- 10 CFR Part 52, Subpart C
- 10 CFR Part 50 (50.33, 50.34, 50.47, App. E)
- 10 CFR Part 100 (100.3, 100.21(g))
- DHS – 44 CFR Parts 350, 351, 352
- NRC and DHS use NUREG-0654/FEMA-REP-1 and supplemental information in applicable NUREGs, GM, and other generic communications)

# C.I.13.3.1, Application Content to Address Emergency Preparedness

- Site Emergency Plan and other incorporated references (include copies of State/local plans, ETE, etc.)
- Proposed EP ITAAC / license conditions
- General & technical requirements specified in the regulations
- Implementation milestones

# C.I.13.3.1, Application Content to Address Emergency Preparedness

- Incorporated or referenced information should be
  - (1) applicable to the proposed site
  - (2) up-to-date, and
  - (3) reflect use of the proposed site for a new reactor
- Applicant must provide justification/analysis to support use of information

## C.I.13.3.2, Emergency Plan Multi-unit Site (Use of Existing E-Plans)

- Applicability of the existing E-plan
- Any required updates to facilities/equipment
- Changes to existing onsite/offsite emergency response arrangements/capabilities (including updated LOAs/certifications)
- Applicability of existing 10/50 mile EPZ's and ETE
- Exercise requirements for co-located licensees (App. E)

## C.I.13.3.3, Emergency Planning ITAAC

- *Proposed* 10 CFR 52.80(b) – ITAAC
- SECY-05-0197 and 2/22/06 SRM – programmatic ITAAC for Emergency Planning
- COL generic EP ITAAC – Table 13.3-1
- ITAAC guidance – C.I.14, C.II.2, C.III.7
- *Proposed* 10 CFR 52.17(b)(3) – ESP's with major EP features and complete and integrated plans to include EP-ITAAC
