

Dear Mr. Hatten:

We are writing on behalf of our clients, Linco Research, Inc., a Missouri corporation ("LRI") and LINCO Diagnostic Services, Inc., a Missouri corporation ("LDS"). Pursuant to a Stock Purchase Agreement dated March 23, 2006, by and among (i) Ronald L. Gingerich, an individual resident of the State of Missouri, (ii) the Ronald L. Gingerich Revocable Living Trust dated May 23, 1995, a revocable living trust created pursuant to the laws of Missouri (the "Shareholder"), and (iii) Upstate Group, L.L.C., a Delaware limited liability company (the "Transferee"), the Transferee, a wholly owned subsidiary of Serologicals Corporation, a public Delaware corporation, has agreed to purchase all of the issued and outstanding stock of LRI and LDS from the Shareholder. The closing of the transaction is scheduled to occur on or about May 2, 2006 (the "Closing"), and in connection with the Closing, we are requesting your assistance in working with the Nuclear Regulatory Commission to obtain renewed and/or re-issued licenses for each of LRI and LDS in anticipation of their respective change of ownership.

Following the Closing, the name of LRI and LDS shall each remain the same and Rick Ryan, the current President of LRI, will serve as the President of each of LRI and LDS. Other key employees of LRI and LDS will remain employed with LRI and LDS, respectively, following the Closing and will be involved in the same activities as those necessitating the original grant of the licenses. No changes will occur with regard to the use of the licenses, the original purpose for which it was granted, or the organization, location, facilities, equipment or procedures that relate to the licenses. The surveillance program at each of LRI and LDS is in good standing at the present time and there will be no changes in the procedures or personnel used in the surveillance program up through and following the change of ownership of LRI and



LDS. The re-issued licenses shall remain in the name of LRI or LDS, as applicable. All records concerning the safe and effective decommissioning of the LRI and LDS facility will be retained by LRI or LDS, as applicable. LRI, LDS and the Transferee will abide by all constraints, conditions, requirements and commitments as previously accepted by LRI and LDS, respectively.

The principal place of business for LRI will remain at 14 Research Park Drive, St. Charles, Missouri 63304. The principal place of business for LDS will remain at 15 Research Park Drive, St. Charles, Missouri 63304. The principal place of business for Serologicals Corporation, the corporate parent of the Transferee, is 5655 Spalding Drive, Norcross, Georgia 30092, and the phone number is (678) 728-2000.
